

OFFICIAL SWEEPSTAKES RULES

PLANTRONICS Headset Sweepstakes

Please read the Official Rules and Regulations ("Official Rules") of the PLANTRONICS Headset Sweepstakes ("Sweepstakes"). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes.

By posting a photo of your workstation or work area on the "Where Do You EggXpert?" thread on www.eggxpert.com, you agree to these Official Rules.

LIMITATIONS ON ELIGIBILITY/AVAILABILITY OF SWEEPSTAKES: Void where prohibited by law. Unless otherwise exempted herein, the Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia age 13 or older ("Entrant"). **This Sweepstakes is void in Rhode Island.** Employees, directors and officers and their immediate families (spouses and siblings, parents, and children and their spouses) and household members of the SPONSOR and/or the ADMINISTRATOR (as each is defined below), and their respective parent companies, subsidiaries and affiliates, distributors, dealerships and companies involved in the implementation and execution of the Sweepstakes (collectively the "SPONSOR") are not eligible. HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE OR IMPROVE YOUR CHANCE OF WINNING. To enter, visit www.eggxpert.com (the "Website") during the Sweepstakes Period, go to the "Where Do You EggXpert?" thread, and post a photo of your workstation or work area on the thread discussion (each such posted valid photo is referred to herein as an "Entry"). **ALL ENTRIES MUST BE RECEIVED BY THE SWEEPSTAKES DEADLINE.** Limit: One (1) Entry per person or email address during the Sweepstakes Period. In the event more than one (1) Entry is received from any one person or email address during the Sweepstakes Period, the first Entry processed will be considered the only valid entry received for that Entry Period.

No copies, facsimiles or mechanical reproductions of entries will be accepted. SPONSOR expressly reserves the right to disqualify any Entries, in its sole discretion, that do not meet the posted photo entry guidelines, or appear to be generated by a so-called "spam" or automated e-mail program or via scripts and automated submission.

Total approximate retail value ("ARV") of all prizes offered: \$180.00 USD. Entries and prizes are nontransferable. All prizes will be awarded. No substitutions are permitted, except that SPONSOR reserves the right to substitute a prize of equal or greater monetary value or cash value for any prize. Winners shall be responsible and liable for all federal, state and local taxes on the value of their prize.

WINNER SELECTION: A random drawing will take place within 10 business days after the Sweepstakes entry deadline from among all eligible entries received. The drawing will be conducted by the ADMINISTRATOR at the Administration address. The decisions of the ADMINISTRATOR are final and binding in all matters relating to this Sweepstakes. The potential winners will be notified by the ADMINISTRATOR by telephone (if available), email and by a one-time publication of the names of the winners on the Website. Prize winners must claim their prizes within seven (7) business days after being notified of winning and must take delivery of the prize within thirty (30) days. A winner's failure to respond to the prize notification within the specified seven (7) business days will be considered such winner's forfeiture of the prize and an alternate winner may be selected from the pool of eligible Entries.

GENERAL CONDITIONS AND RELEASES: An entrant or winner may be disqualified from the Sweepstakes if he or she fails to comply with each provision of these official rules, as determined in the sole discretion of SPONSOR.

In the event more than one (1) Entry is received from any one person or email address during the Sweepstakes Period, the first Entry processed for Entry Period will be considered the only valid entry received for that Entry Period. In the event of a dispute regarding the identity of the person submitting the entry, the entry will be deemed to be submitted by the person whose name is registered to the e-mail account, and should the person not be able to prove his/her identity against the registered name the entrant will be rejected and result in the disqualification of the entrant from the Sweepstakes.

Entries not complying with all rules are subject to disqualification.
