# "Newegg's First Video Contest" – Official Rules

**CONTEST DESCRIPTION:** The Contest begins at 12:00:01 PM Pacific Standard Time ("PST") on March 28, 2008. The deadline for entry submissions to participate in the Contest ends at 11:59:59 PM PST on April 25, 2008 or upon the receipt of one thousand (1,000) entries, whichever occurs first ("Contest Period").

**ELIGIBILITY:** The Contest is open only to legal residents of the United States and District of Columbia ("U.S.") who are at least fourteen years of age on the date of the Contest entry submission ("Entrant"). - 5. It must be your original work and must not contain images, music, words, ideas, choreography or direction of any other person, unless you have explicit written permission to use the same for this Contest and which complies with these Official Rules in the sole discretion of Administrator;
- 6. It must not violate or infringe any third party's rights, including but not limited to, copyright, trademark, right of publicity, right of privacy or trade secret, and must not in any way violate any applicable laws or regulations;
- 7. It must not contain any content or performance that is sexually explicit, offensive, illegal, pornographic or obscene;
- 8. It must not contain libelous, slanderous or defamatory materials or statements, including but not limited to words or symbols that are widely considered offensive to individuals of a certain race, gender, ethnicity, national origin, religion, sexual orientation or socio-economic group;

**HOW TO ENTER:** To enter the Contest, visit www.newegg.com (the "Website") during the Contest Period, submit a Qualifying Video (as defined below) with the required contact information ("Entry") and submit the completed Entry as directed. Only the first one thousand (1,000) eligible Entries will be accepted for judging. In the event the Administrator does not receive 1,000 entries, then ALL ENTRIES MUST BE RECEIVED BY NO LATER THAN 11:59:59 PM PST on April 25, 2008. Entries submitted after the close of the Contest Period will not be judged and will not be eligible for prizes. To submit a Video, the Entrant must be a registered member of newegg.com. Limit: One (1) entry per person or email address during the Contest Period. All Qualifying Videos received during the Contest Period will be judged by a panel of judged comprised of Newegg representatives ("Judging Panel"). The Judging Panel will choose the top twenty video submissions and award prizes accordingly. In choosing the winning videos, the Judging Panel will base its decision on originality and creativity, description of Newegg, reflection of Newegg's strong suits, technical execution and overall appeal. The winners will be announced on the Website on or about May 30, 2008.
