**DATES OF PROMOTION:** The “Legendary PC” Giveaway (the “Promotion”) begins at 12:00am Pacific Time (“PT”) on June 11, 2019 and ends at 11:59pm (PT) on July 8, 2019 (“Promotion Period”), subject to entry period dates and times as outlined in the “ENTRY PERIODS” section below. All Entrants (defined below) must have access to the Internet in order to enter. Normal Internet, phone and usage charges imposed by your online or phone service provider may apply.

**ELIGIBILITY:** The Promotion is open only to legal residents of one of the fifty (50) United States, the District of Columbia who are 18 years of age or older or the age of majority in their state at the time of entry (the “Entrant”).
